Report

Preparatory session

The chairman of the evaluation committee showed the committee members the tender documentation and explained the technical characteristics of the requested supply or service, explaining its use, the type of humanitarian intervention and the implementation area of the activities.

Deadline for submission of bids

As of 29/05/2025 at 10:00 (UTC +5:30), the evaluation committee confirms that five (5) tenders have been received in sealed envelopes, indicated below according to receipt chronology:

Opening of envelopes for the evaluation of the selection criteria

At 10:00, the evaluation committee checks the EDES database (available at the following link:

https://commission.europa.eu/strategy-and-policy/eu-budget/how-it-works/annual-lifecycle/implementation/anti-fraud-measures/edes/edes-database_en) and declares that none of the participants are excluded or subject to financial penalties by EU.

At 12:20, after careful analysis of the administrative documentation received with the help of the checklist (selection criteria compliance grid) attached to this report, the evaluation committee declares that:

- SBS.Com Office Automation (Pvt) Ltd needs to integrate Manufacturer Authorization letter and the documentation about past experience requested to participate to Lot n.1.
- Ceylon Business Appliances (Pvt) Ltd needs to integrate the Legal Entity Form, the Manufacturer Authorization letter and the documentation about past experience requested to participate to Lot n.1.
- Singer Sri Lanka PLC needs to integrate the certificate of issue of Business Registration number, Manufacturer Authorization letter and the documentation about past experience requested to participate to Lot n.1.

- Oquraa Computer complies with all the requirements and is admitted to the next phase.
- Huawze (Pvt) Ltd needs to integrate the certificate of issue of Business Registration number, Manufacturer Authorization letter and the documentation about past experience requested to participate to Lot n.1.

The companies which do not comply with the requirements are called and asked to integrate the needed documentation.

At 12:32 Ceylon Business Appliances (Pvt) Ltd is admitted to the evaluation phase after being asked to integrate documentation about the past experience requested to participate to Lot n.1. The documentation and the email they sent are added to the tender documentation. The company didn't include the Legal Entity Form among the documentation, but it included the Business Registration certificate which proves their legal status. The committee decided that the company will be asked to provide the dully filled and signed Legal Entity Form in case their offer will be awarded.

At 13:10 Huawze (Pvt) Ltd is excluded from the evaluation phase, provided that they explained via phone call that at present date they are still not registered as a business due to government delays.

Given that the documents requested are easy to retrieve if existent, the companies SBS.Com Office Automation (Pvt) Ltd and Singer Sri Lanka PLC are admitted to the evaluation phase with reserve.

At 15:48 SBS.Com Office Automation (Pvt) Ltd integrated the documents requested via email. The documentation and the email they sent are added to the tender documentation.

At 16:15 Singer Sri Lanka PLC integrated the documents requested via hand delivery to the Mannar office.

Opening of envelopes for technical evaluation

At 13:15 a careful analysis of the technical offers was performed by the evaluation committee.

Offers number #2 and #3 are found to miss in every lot some of the items requested in the Annex 1 of the Tender Dossier. The same is true for the offer #4 for the Lot #3. This states these offers as not-compliant, therefore they are excluded in accordance with section 4.3.9.4. of the PRAGs (Evaluation of technical offers) and therefore not further evaluated.

Offer number #1 (for lot #1, #2 and #3) and #4 (for lot #1 and #2) were found to miss some small information that were hindering a proper evaluation. The respective companies were contacted. The information needed were:

Offer #1 (SBS.Com Office Automation (Pvt) Ltd):

- It is not clear if MS Office (genuine) is included in the desktop computers as requested in Annex 1.
- It is not clear if the installation is included in the offer as requested in the additional services of the Annex 1.
- Delivery time is not specified.
- The technical sheet of the item #1 offered in the Lot #2 is missing.

- Warranty for laptops is not specified.
- The item #8 offered in Lot #1 and the item #2 offered in the Lot #2 are the same, but the price is different.
- It is not clear if the monitors offered are FHD as requested in the Annex 1?
- It is not clear the model of the item #5 offered in the Lot #3.

Offer #4 (Oquraa Computers):

It is not stated if the prices include VAT.

At 16:40 Oquraa Computers was contacted via phone call and they confirmed that the prices include VAT.

On May 30th, 2025 at 9:27 SBS.Com Office Automation (Pvt) Ltd integrated the documents requested via email. The documentation and the email they sent are added to the tender documentation.

At 14:30 the committee reunited again, finished the technical evaluation and admitted the offers #1 and #4 to the financial evaluation.

Opening envelopes for financial evaluation

After careful analysis of the proposed prices the evaluation committee in accordance with the tender dossier, the evaluation committee confirms that the final scores are the following (in score order):

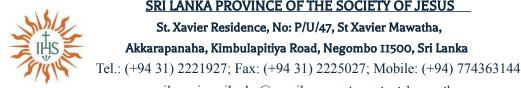
