After careful analysis of the proposed prices the evaluation committee in accordance with the tender dossier, the evaluation committee confirms that the final scores are the following (in score order):

#### Conclusion

"The Evaluation Committee justifies the decision not to select the lowest-priced proposal on the basis of the quality/price ratio, in full compliance with the applicable procurement guidelines. As reflected in the evaluation report, the technical specifications of the lower-priced offers were found to be of low standard after thorough analysis."

The evaluation committee therefore, given the results reported above, proposes to award the works in question to the company **Nuwani Construction (PVT) Ltd**, according to the offer n° 3° described above.
